WHATS NEW:

YEAR-END IS QUICKLY APPROACHING:

The University Financial Services (UFS) Fiscal Year 2021-22 Closing Schedule has been published and is available on the [UFS website](#). The schedule provides a full list of deadlines and related information for all business transaction types. For ease in reference, deadlines related to Concur Travel and Expense reports have been summarized here within.

REMINDERS:

YEAR-END DEADLINES FOR CONCUR EXPENSE REPORTS

It is imperative for the annual closing process for the University to adhere to appropriate fiscal year cutoffs. Old year transactions must be recorded in the account records of fiscal year 2021-22 and new year transactions must be recorded in the accounting records of fiscal year 2022-23.

To ensure that General Expense Report transactions are recorded to the appropriate fiscal year, old year and new year transaction dates must be allocated on separate reports. To remain compliant, follow the guidance stated below to ensure accurate and timely postings of General Expense Report transactions:

Concur General Expense Reports	Deadline/ Due to APS
Expense reports with transaction dates prior to June 1 st	06/15/22
Expense reports with transaction dates June 1 st to June 15 th	06/30/22
Expense reports with transaction dates June 16 th to June 30 th	07/07/22*

To maintain compliance and ensure that Travel Expense Report transactions are recorded to the appropriate fiscal year, follow the guidance stated below:

Concur Travel Expense Reports	Deadline/ Due to APS
Expense reports for travel completed prior to June 1 st	06/03/22
Expense reports for travel completed June 1 st to June 15 th	06/17/22*
Expense reports for travel completed June 16 th to June 30 th	07/07/22*

*4:30 p.m. deadline

IMPROVING THE TIMELINESS OF REPORTS IN THE CONCUR WORKFLOW CYCLE

Cardholders and delegates must fulfill their responsibility of ensuring that all available transactions are submitted on an expense report, continue to follow the transactions throughout the workflow process, and promptly address any issues or comments that are noted within the report to ensure that all transactions are fully posted into SAP in a timely manner.

Apart from following the year-end closing schedule, all procurement card transactions associated with a General Expense report should be allocated and fully posted into SAP by the 15th day of the following month. Travel Expense reports created for day trips (mileage only) should be submitted monthly. All other Travel Expense reports should be submitted by the traveler *directly* after returning from a trip. Reports submitted after 60 days from the last day of travel are subject to taxation of reimbursement.

Refer to [Procurement Cards BPM E-7-16](#), [Procurement Card Manual](#), and [Reimbursement of Travel Expenses BPM E-5-1](#) for any additional guidance regarding to the frequency and timeliness of reports.

Additionally, to improve efficiency and timeliness of expense report processing, it is recommended that when an individual (department or processor) rejects/returns a report that clear, concise direction as to why the report is being returned is included in the comments section. For example, if a report is returned due to an error with a specific transaction, include detail of the issue as well as pinpoint which transaction is at question within the report. It is equally important that when the user receives the returned report that they fully address all items being presented in the comments section prior to submitting the report again. Fully employing this recommendation will reduce multiple returns for one given report and improve both timeliness and efficiency for all those involved.

TOP 5 ITEMS FOR APPROVERS TO WATCH FOR DURING REVIEW THAT COULD CAUSE THE REPORT TO BE RETURNED

1. The procard transaction does not include a business purpose. See the [Procurement Cardholder Manual](#) for the definition of a business purpose.
2. The procard documentation does not contain an itemized receipt. See the [Procurement Cardholder Manual](#) for the procard documentation standards.
3. The procard documentation attached to the expense does not match the expense amount.
4. The travel expense report does not contain a business purpose.
5. Discretionary expenses need to be allocated to discretionary funds per [BPM E-7-10](#).

HOW TO DETERMINE WHEN IT IS ALLOWABLE TO USE A PROCUREMENT CARD

Accounts Payable Services and the Purchasing Division partner in working together to maintain the Procure-To-Pay Purchasing/AP Quick Reference Guide. The guide provides clear, concise direction when determining the appropriate purchasing method when conducting transactions on behalf of the University. When indicated on the guide that procurement card use is allowable to procure a specific goods or service, it would be University's preferred payment type over others. Utilization of the procurement card increases the efficiency of the purchase and payment of small dollar acquisitions and is the primary purchasing method for delegated small dollar purchases.
